




- (b) fish gelatine or Isinglass used as fining agent in beer and wine;
- 5. Peanuts and products thereof;
- 6. Soybeans and products thereof, except:
- (a) fully refined soybean oil and fat;
- (b) natural mixed tocopherols (E306), natural D-alpha tocopherol, natural D-alpha tocopherol acetate, and natural D-alpha tocopherol succinate from soybean sources;
- (c) vegetable oils derived phytosterols and phytosterol esters from soybean sources;
